Papers must not contain any indication of authorship and must not be published or submitted elsewhere. Manuscripts should normally not exceed 9,000 words, including footnotes and bibliography, and should be formatted according to Chicago style. Papers may be written in either English or French. All submissions will be acknowledged. Please include both email and postal addresses in the cover message.

## AGM 2012 MINUTES

#### Canadian Society of Medievalists/Société canadienne des médiévistes Annual General Meeting – May 28, 2012

- 1. Approval of Agenda: moved by Melissa Furrow, Serina Patterson
- 2. Approval of minutes of 2011: moved by Markus Stock, David Porreca; corrections made, including re. item #8 "Officers": the *Florilegium* editor's 3<sup>rd</sup> term is three (not two) years, with the possibility of leaving after the second year depending on the availability of institutional support;
  Minutes approved as corrected.
- 3. President's Report

Elizabeth Edwards: thanks to executive of CSM, sec-treasurer Marc Cels & Kathy Cawsey; VP John Osborne; PP Anna Smol; *Florilegium* editor Christa Canitz; local co-ordinator Jim Weldon. Serina Patterson for website management & for posting things; Sebastien Rossignol for French translations & connections. Pleased with quality of papers at Congresses.

Ongoing challenges: membership drive, especially French members; concern about next year re: sessions in French (given the location on the West Coast). Hopeful website will bring us new members and links to other organizations.

Changes resulting from website: *Scrinium* – members' news now on website; *Scrinium* will now be a link rather than an attachment.

4. Sec-Treas Report – Kathy Cawsey

**Summary** – Thanks to Marc Cels. Website has been major business; thanks to those who helped. Overall finances are okay but need to increase membership. Travel fund is an issue – must spend full amount. **Full report submitted.** 

Motion to assign the following priority to any available travel funds: grad students; unfunded members of the Executive; unwaged & underwaged; otherwise unfunded faculty. Moved Elizabeth Edwards seconded David Porreca. Friendly amendment by Markus Stock. Carried.

Question – could it be applied to a prize? ans. no

Discussion over whether people could know how much money would be available before coming to Congress. It would be helpful even to know past practices re: the money – attempt to make it less hazy. Make it clear that there is money available. John Osborne: to grad students – make sure you ask your Dean of Grad Studies for money.

#### Motion to accept sec-treas rept David Porreca; Jim Weldon. Carried.

5. Florilegium report — Christa Canitz

Developing Florilegium's Open Access website and electronic archives has been a major project during the last two years; all back issues (back to 1979) have been digitized, and 22 of the 27 volumes to date have been posted. Abstracts are included for the most recent 7 volumes. The site is well used. Now that most of the 500+ author contracts are in place, the next step towards the long-term goal of expanding Forilegium's e-presence is to sign agreements with aggregators and consortia so that Florilegium will be part of a subscription package, for increased income and dissemination.

The other major job this past year was the publication of vol. 27 (2010), which went to press in Nov. 2011 and was published in early May. The next volume, vol. 28 (2011), which is now in preparation, is a history volume in memory of Margaret Wade Labarge — with clusters on women's history / medical history; it is being co-edited with Jacqueline Murray. Vol. 29 (2012) will be broad-based again, continuing the alternating pattern with more specifically-focused volumes; additional submissions (especially arising from this conference) are encouraged. Colour plates, maps, and other illustrative materials are welcome. The journal fell behind 7 or 8 years ago, and while 7 vols have been produced in the last 7 years, it is taking longer than hoped to catch up since the *e-Flor* project has been very time-consuming. Catching up is the next project.

In the 2011 SSHRC competition *Florilegium* narrowly missed the cut-off for a grant (by 0.4 points) — disappointing because the previous grant was our largest ever — but the application is being reviewed. Content quality is good (scoring 5.05 of max. 6 points), but *Florilegium* needs to prove at least 250 regular readers (i.e., CSM/SCM must increase its membership to at least 170 members). In the meantime, *Forilegium* has enough of a contingency fund to cover vol. 27 plus two further volumes, till the next SSHRC competition.

Question: Cynthia – have you attempted to track who sits on the journals committees? CC – apparently, this information has just been posted this morning. Cynthia: Medievalists need to be well represented – when SSHRC comes knocking say 'yes'.

Markus: 7 vols in 7 years – concerned we are 2 years behind because optics are bad – prognosis for when caught up? CC – yes, now that electronic project is almost done will turn to trying to catch up again.

#### Motion to accept report David Porreca; seconded by Sebastien Rossignol. Carried.

6. CFHSS Report – John Osborne

**Summary:** More than any time in history lobbying Ottawa important; CFHSS doing a good job doing that lobbying. After budget everyone expected it to be far worse. **Full report submitted.** 

#### Motion to accept: Cynthia Neville; seconded Serina Patterson. Carried.

  - a. Labarge have fallen behind; 2010 prize awarded this year; 2011 to be awarded next year; next Labarge prize chair has a plan for timely delivery of prize giving a cut-off date for books to be received by Dec. 15.

Report: 2010 prize go to Frank A. C. Mantello & Joseph Goering, Letters of Robert Grosseteste, UTP. EE – motion to approve the nomination; seconded John Osborne. Carried.

- 9. Website Report Serina Patterson & Kathy Cawsey launched the website and ran through the key aspects & how-to's.
- 10. Members' News put it on the website!
- 11. Federation Update Graham Carr (president)

Congress: 75 million dollars in SSHRC partnership grants announced by industry minister. Over 7,000 delegates here. Interesting major speakers & talks.

Issues: 2012 federal budget — mixed signals: good news re: sustaining of funding for Tri-Council & Canadian Foundation for Innovation; operational cuts to SSHRC but research protected. Insight grants; talent grants etc. all protected. Bad news — other agencies cut (eg. National Library & Archives, CBC, Parks Canada etc.). Will be talking about ways federation can help. 3-year funding grant renewed & grant for scholarly publications renewed.

Active year re: advocacy on parliament hill (copyright policy, r&d policy, pre-budget advocacy). Big thinking lecture series on Parliament Hill raising visibility for Social Sciences & Humanities – turning people away at the door.

Changes to governance model – overhaul of web presence; adopted new selection process for choosing site of Congress in future (starting 2017) – any university or conference centre can bid to host Congress. Working with associations to provide member benefits (eg: insurance policy).

#### **Submitted Reports**

#### Report on CFHSS meeting — John Osborne

The annual meeting of the General Assembly of the Canadian Federation of the Humanities and Social Sciences (CFHSS) took place in Montréal on Thursday March 29<sup>th</sup>, 2012.

In a morning panel, officers from three constituent associations of differing sizes spoke about the challenges of maintaining membership, and a strong suggestion was made to encourage multi-year memberships at a slightly discounted rate. This was seen to even out the fluctuations in years when those not planning to attend Congress choose not to renew.

This was followed by a presentation on the new Canada "Not-for-Profit Corporations" Act, which came into effect in October 2011. All existing entities governed by this act must comply with the new legislation within three years, or will be legally dissolved.

Finances: The Federation posted a small operating deficit for the previous year, in part due to the location of Congress 2011 (Fredericton) which attracted fewer delegates than usual.

Incoming officers: President-elect is Antonia Maioni (McGill); VP Development is Doug Peers (Waterloo); VP Equity Issues is Lynn Wells (FNUC).

The CFHSS is moving to dramatically reduce the size of its Board of Directors.

Forthcoming Congresses will be held at the University of Victoria (2013), Brock University (2014), and the University of Ottawa (2015).

The Federation has admitted two new institutional members in Alberta – Mount Royal University and Grant MacEwan University – thus bringing the membership total to 81 institutions and 82 societies.

Principal ongoing activities include: lobbying government on funding and on copyright, and working to resolve SSHRC-CIHR issues over funding for health-related research.

#### **Boyle Report** — David Watt

Leonard Boyle Dissertation Prize Committee Members: Ivana Djordjević, Michael Fournier, David Watt (Chair)

Report: All four dissertations submitted for consideration for the Leonard Boyle Dissertation Prize this year were very strong. It was a privilege to read these dissertations and to learn about the substantial research these promising scholars have undertaken. After careful deliberation, the committee decided unanimously to award the prize to Giselle Gos for "Constructing the Female Subject in Anglo-Norman, Middle English and Medieval Irish Romance." Dr Gos wrote her dissertation as a student in the Centre for Medieval Studies at the University of Toronto under the supervision of Suzanne Conklin Akbari. The chair would like to congratulate all of the authors who submitted

dissertations this year on their work. The chair is also very grateful to the members of the committee, who put a great deal of effort into evaluating the dissertations in a timely manner.

Award Citation: In her Ph. D. dissertation, "Constructing the Female Subject in Anglo-Norman, Middle English and Medieval Irish Romance," Dr Giselle Gos argues that "the absence of female subjects in medieval romance is not due to an absence in the texts themselves, but rather to limitations in the theoretical paradigms that have been used to analyze gendered and sexed subjectivity." Throughout her dissertation, Dr Gos boldly engages with a range of contemporary scholars, developing an original question in response to the current state of criticism and drawing on detailed evidence to formulate her response. She invites readers to question received views about female subjectivity in medieval romance because, she argues, such views rely heavily on versions of these texts privileged by modern editors and readers. Dr Gos's dissertation develops a highly nuanced understanding of women's roles in romance and society by comparatively studying variant manuscript copies of romances in several languages (three in the case of Gui de Warewic, Guy of Warwick, and The Irish Lives of Guy of Warwick). Her awareness of the limitations of published sources and her ability to draw with ease on unpublished ones greatly enriches her argument, and her remarkable linguistic expertise "allows her to move easily and confidently between texts in three medieval languages, and shed light on textual intersections inaccessible to others." The committee commends Dr Gos's dissertation as an exceptional piece of scholarship and a very valuable contribution to scholarship on medieval romance.

#### Margaret Wade Labarge Book Prize, 2010 — W. Schipper

Prize winner: Frank A.C. Mantello and Joseph Goering, *The Letters of Robert Grosseteste* (Toronto: University of Toronto Press, 2010)

#### Brief Committee Report:

It was not a simple matter to come to a decision on a prize winner, in part because of the number of entries (7 books in total). In the end there were three books we thought had more merit than the others. From that shortlist we chose the translation of the Grosseteste letters because the editors/translators provided a very informative introduction, and the book is relevant to medievalists working in a number of areas. The commentaries and indices in particular are very useful. One question raised by the committee was the problem of awarding a prize to a book that consists in part of translations. But in the end we felt that this particular book, because it provides translations of the letters of an important and influential figure from medieval England, would appeal not just to those who are able to work with Latin texts, but also to a wider audience that cannot.

#### <u>Financial Report June 2011-May 2012</u> — Kathy Cawsey

Kathy Cawsey resumed her post as secretary-treasurer after Marc Cels' two-year term.

The major work this year has been developing and launching the new CSM/SCM website. Serina Patterson must be acknowledged for the work she put into the site, and the assistance she has provided me (and everyone) in figuring it out. Thanks are also due to Jim Weldon, who helped in the transition from the old site to the new one (not to mention maintaining the original site for numerous years); and to the Board, who test-ran various aspects of the site. Serina and I spent months working out the bugs, setting up Paypal, linking it to the CSM bank account, and then informing everyone of the site and encouraging them to pay via the site rather than using traditional methods. I am happy to report that the site does make processing memberships considerably more streamlined than previously. As of

last week, 50 members had paid via the website, and I hope this number will increase for next year.

While the website has been adequately used for registration, so far the site has been underused for other purposes. We hope that after the launch here at Congress, people will be encouraged to post CFPs, job opportunities, conference announcements and research opportunities on the site. We also hope people will start checking it regularly, or, even better, sign up for our RSS feed. We hope the site will be the 'go-to' place for Canadian medievalists and for those wishing to find out what's happening in Medieval Studies in Canada.

Membership numbers have been relatively steady over the past few years. (This year's numbers look lower but do not include PIMS memberships nor people paying at Congress.) We hope the new website will increase membership, but so far this has not been the result. Our goal continues to be to have every medievalist in Canada a member of the CSM/SCM, and this will not happen if people perceive the point of joining to get Florilegium or to come to Congress. Instead, we need to convince colleagues that the society is valuable year-round, as a place to network, find research partners, keep abreast of scholarship in Canadian medieval studies, and so on. We therefore need people to post all this information on the website, so that when people check us out they see that we are far more than just Congress and Florilegium.

One issue is the SSHRCC travel fund. We have not been spending as much as they have been giving us, and so rather than commending us for our thrift, they have cut our grant. We still have a designated surplus of over \$5000.00, which cannot be spent on anything else. (Indeed, it is this travel fund which is making our finances look considerably rosier than they actually are.) We recently looked at the wording and noted that travel grants could be given to anyone in need, not just students (eg. retired/unwaged, underwaged, etc.). Thus we would encourage all and sundry to apply for the travel grants, so we can both use up the surplus and increase our grants for future years.

Overall, thanks in part to Marc Cels' careful management, our finances are in decent order, but we are always threatened by the lost of the SSHRCC grant for Florilegium, which we simply could not afford. A more solid membership base would help immeasurably.

### PRIX LEONARD E. BOYLE PRIZE

Le prix Leonard E. Boyle est décerné à une thèse de doctorat méritoire dans n'importe quel domaine des études médiévales rédigée par un(e) citoyen(ne) ou résident(e) du Canada. Les thèses seront évaluées par un jury constitué par les membres du sous-comité de la Société canadienne des médiévistes, et le prix sera présenté à l'Assemblée annuelle générale. En plus du prix en espèces, le prix Boyle consiste en l'adhésion pour trois ans à la Société ainsi q u'à l'abonnement à la revue *Florilegium* et au bulletin *Scrinium*, pendant la même durée.

The Leonard Boyle Dissertation Prize is awarded to a deserving doctoral thesis in any field of medieval studies produced by a Canadian or someone resident in Canada. Entries are adjudicated by the Dissertation Prize Committee, a subcommittee of the Canadian Society of Medievalists, and the prize will be presented at the annual meeting of the Society. The Prize itself consists of a cash award as well as a membership in the Society for three years. Members automatically receive copies of the journal *Florilegium* and the newsletter *Scrinium*.
